RIGHT-OF-WAY VACATION INFORMATION

General Information: A right-of-way vacation is when a property owner can have the public's interest in a right-of-way removed. This can result in the vacated right of-way being purchased by the neighboring property owner to become part of their property. The value of the right-of-way is determined by averaging the land values of the surrounding properties. Applications for requesting a right-of-way vacation within the City of Cedar Falls will be considered when all required documents and fees are submitted. Requests are reviewed by city staff, Planning and Zoning Commission, and City Council. This process typically takes three to four months. It is highly recommended that the applicant or a representative be present at each meeting.

Examples when a vacation would be appropriate (this list is not all inclusive):

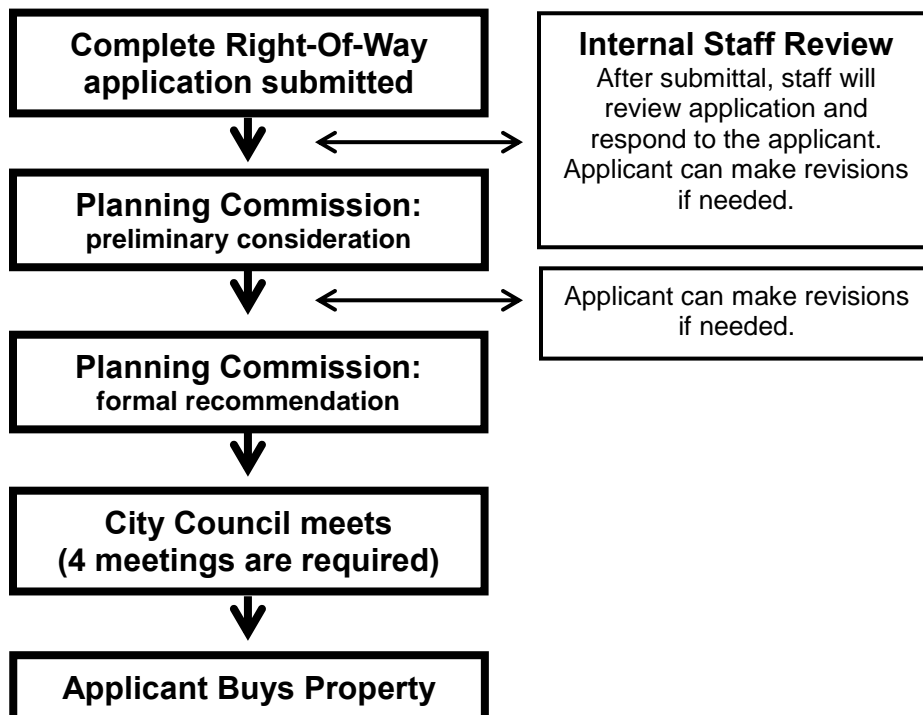
- Current access easement has not been used or never been improved
- Easement only really needed for utilities

Partial vacations are strongly discouraged.

Deadline: Applications must be submitted by 12 PM (noon) on the second and fourth Wednesdays of the month; see Planning and Zoning Commission Schedule of Applications.

Application Submittal Instructions: Submit all required documents with fee to the Planning and Community Services Division and email to planning@cedarfalls.com by the deadline. An application checklist is provided to assist in a complete submittal.
